The buyer, _____, agrees to the following:

CONDITIONS OF SALE

The buyer agrees that the kitten is being purchased as a companion/pet only and that no rights for breeding is given. The buyer also acknowledges that the kitten is a lifetime commitment, and should the buyer be unable to keep the kitten/cat, the buyer will return it to the seller (who has the first option), at any time of the kitten's/cat's lifetime, at no charge.

The kitten/cat will, under no circumstance, be sold, leased or given to any pet store, research facility/laboratory, animal shelter/humane society or any other similar facility. That the kitten/cat will not be abused by anyone or any other animal, nor be neglected or harmed in any way or situation.

The buyer is not to have the kitten/cat declawed or devocalised.

The kitten/cat is strictly an indoor pet, and never to be allowed to roam freely outdoors, except in an enclosed run or be in a harness/leash for outings.

HEALTH GUARANTEE:

The seller guarantees that this kitten is healthy to the best of her knowledge. The seller guarantees that the kitten has been fully vaccinated.

The buyer should have the kitten examined by a certified veterinarian within 72 hours of purchase. Should the veterinarian discover any health concerns, the buyer will return the kitten to the seller within 7 days, with a written explanation from the veterinarian. The buyer will not be reimbursed for any travel or veterinarian charges. The seller will replace the kitten with another of equal quality if and when one becomes available.

If the kitten dies within the first year of its life due to inherited genetic diseases, the buyer must inform the seller and provide a necropsy from a certified veterinarian. The seller will replace the

kitten with another of equal quality if and when one becomes available.

The seller also guarantees that the kitten has been neutered and microchipped. The seller will also provide CFA registration papers within 30 days of purchase.

CARE

The buyer agrees to provide the kitten/cat, throughout its lifetime, proper food, accommodations, annual vet examinations and vaccinations, as well as ongoing vet care as and when needed. Annual vaccinations should include:

Rabies

Panleukopenia pneumonia, Rhinotracheitis and Calici Virus (usually a combination).

Feline Leukemia (FeLV) is optional and you should consult your vet about it. Make sure it's not a live virus.

The seller is not in favour of vaccinations against: Feline Infectious Peritonitis (FIP).

Should the buyer choose to vaccinate the kitten/cat with the vaccination, and the kitten/cat subsequently develops FIP or any related illnesses from the abovementioned vaccine, the seller will not replace the kitten/cat.

The buyer will inform the seller of any change in address, telephone number/s and email address.
